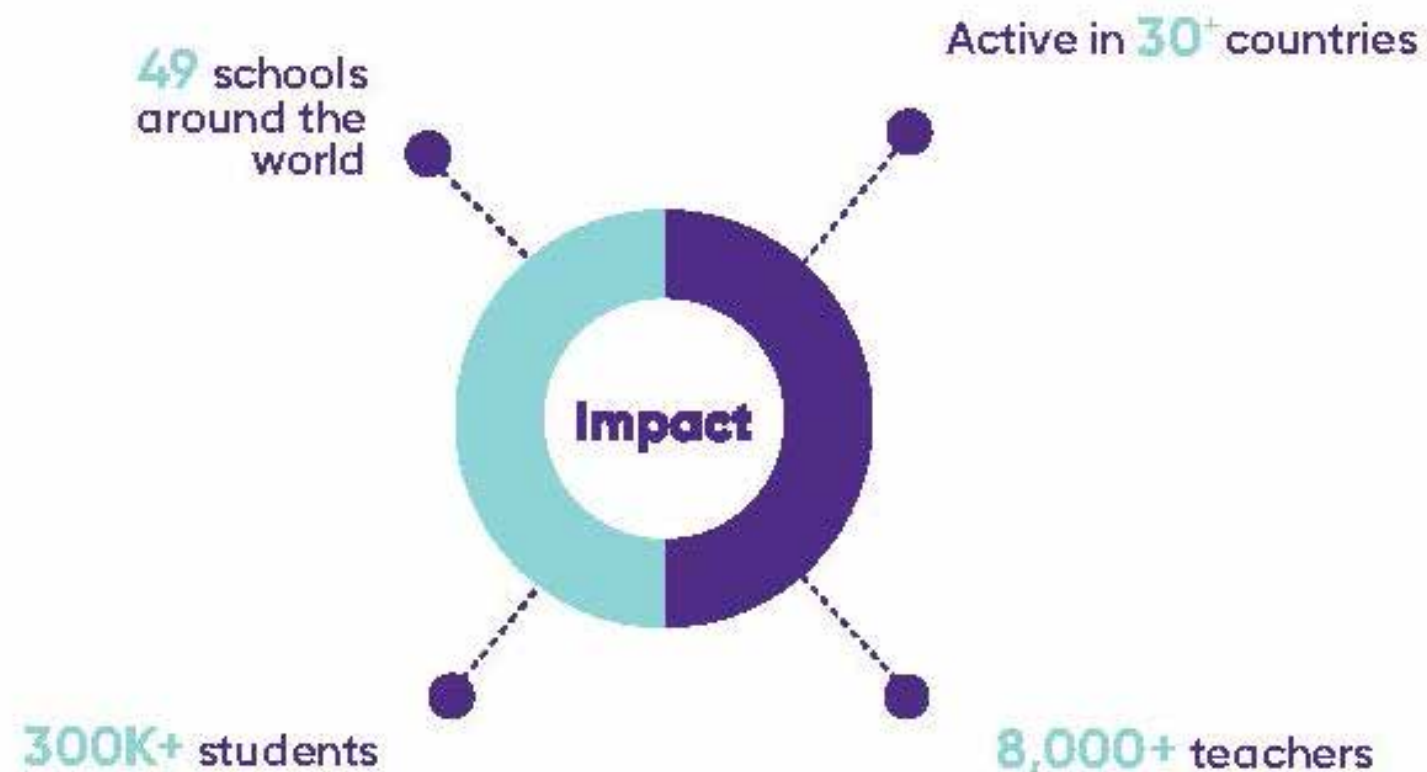

OUR MISSION

ORT'S mission is to increase access to high-quality education leading to professional success and economic independence.



What We Do

Following World War I, we pivoted our mission from supporting Russian Jewry to connecting Jews worldwide. Since then, we have transformed countless lives from underserved communities through access to excellent education.

JEWISH IDENTITY

ORT schools combine excellent general education with formal and informal Jewish studies curricula that include Hebrew language and literature, Jewish traditions and culture, Jewish history and Israel studies. In many communities, ORT is reinvigorating Jewish life by providing students with a sense of Jewish identity, commitment and connection to their fellow Jews around the world.

SHARED KNOWLEDGE

ORT promotes shared experiences, such as our international student programs, teacher training courses and annual ORT Day, to provide opportunities and connect with others.

STEM EDUCATION

Our investment in STEM (Science, Technology, Engineering and Mathematics) tools and education helps students understand important global and local issues, and develop skills in critical thinking and problem-solving that will allow them to participate fully in 21st-century life.

CONTINUING EDUCATION

ORT helps students of all ages prepare for, and keep pace with, the evolving needs of the contemporary workplace through further education and vocational training.



Where We Are

EMPOWERING STUDENTS & TEACHERS

INTERNATIONAL SUMMER SCHOOLS

Our student summer schools in Israel, Panama and Bulgaria use the latest educational technologies to broaden students' knowledge of STEM, ecology and digital skills.

ANNUAL COMPETITIONS

- Harmatz Award for Social Responsibility encourages students to focus on Tikkun Olam projects
- Jewish Animation and STEM Communication awards recognize students who explain a complicated science theme in layman's terms
- Taub Young Entrepreneurship Program promotes business entrepreneurship, motivates students and encourages collaboration.

TEACHER TRAINING

We invest in our educators, providing them with effective tools:

- Teachers visited London in 2019 for the Hatter Technology Seminar, which explores developments in STEM teaching and learning.
- The Leadership Training Program (LEAD) seminar develops ORT's future educational leaders and senior managers.

WORLD YOUTH ENCOUNTER

The 4-day event organized by ORT and Scholas – an international group promoted by Pope Francis – brought 55 ORT students from 9 countries to Mexico City for four days of interfaith discussions and cross-cultural learning.

ROBOTRAFFIC COMPETITION

ORT teams dominated the tenth Nadav Shoham Robotraffic competition at the Technion – Israel Institute of Technology, securing four first-place victories for their entries of electric and efficient small vehicles.

GROWING THE NETWORK

Sir Manasseh Meyer International School (SMMIS) in Singapore and JSG Maimonides Secondary School in Amsterdam joined the ORT network as affiliated schools.

IMPACT IN ISRAEL

World ORT Kadima Mada, our operational arm in Israel, focuses on strengthening the low socio-economic communities in Israel's geographic periphery.

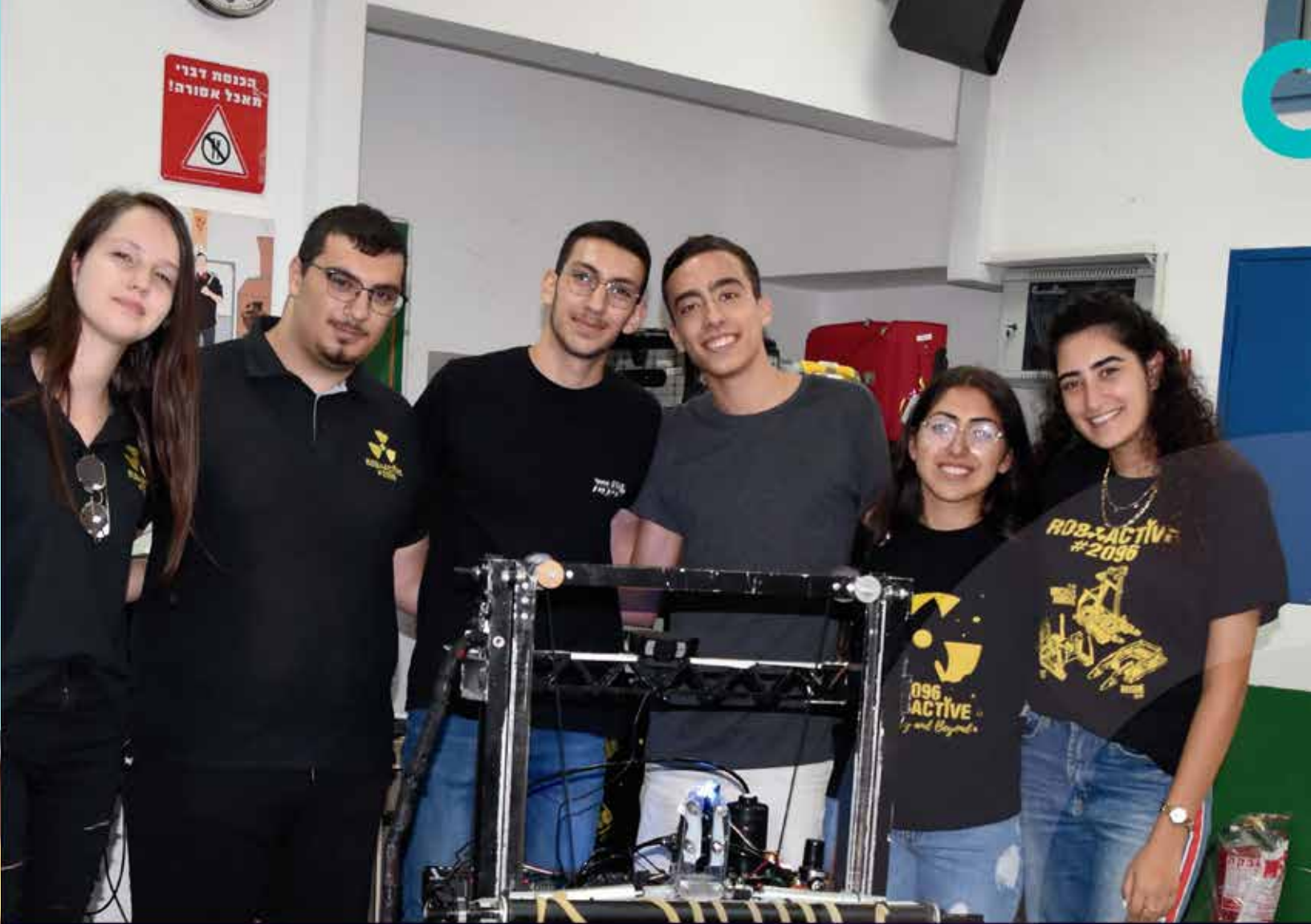
IN 2019:

- World ORT Kadima Mada served 2,100 students and 400 teachers throughout Israel's periphery.
- Levinson and Rabin schools in Kiryat Yam won Ministry of Education awards for outstanding schools in the 2018-19 school year.
- 11 YOUNiversity Excellence Centers offered 45 different STEM courses to more than 6,000 students.
- The RoboActive 2096 team from Dimona won The Engineering Inspiration Award at the 2019 World Robotics Competition for promoting social initiatives that inspire the local community and received a NASA scholarship to finance their 2020 participation fee.
- 125 students at the Be'er Sheva Technological College benefited from the Ashbal program, which supports individuals from Bedouin communities in the Negev.

KFAR SILVER YOUTH VILLAGE

In 2019, ORT America embarked on a \$1 million challenge to renovate the kitchen and dining hall at Kfar Silver, a rural day and boarding school in Southern Israel. 214 of the nearly 700 students aged 12-18 board at Kfar Silver.

With your help, we met our ambitious goal, expanding the dining hall capacity while providing a safe, welcoming space for meals, homework, tutoring and celebrations. The renovation is part of a multi-year, multi-million-dollar effort to upgrade and enhance the campus, which features an organic dairy and agricultural farm that are maintained by the students.

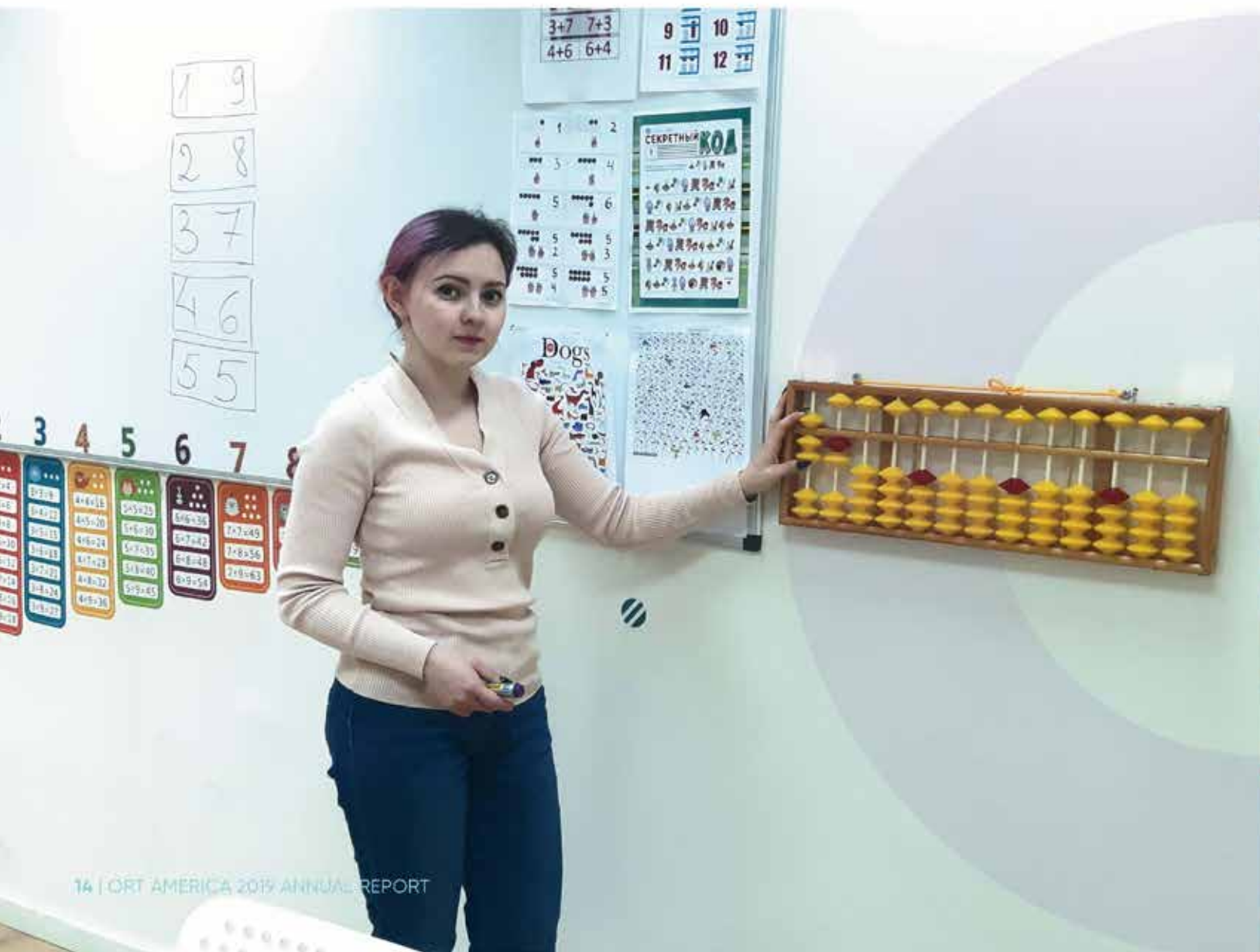

LOOKING TO THE FUTURE WITH THE ANIÈRES ELITE ACADEMY

The Anières engineering and technology scholarship program in Israel provides opportunities for talented teenagers from around the world to pursue careers as scientists and engineers.

GRADUATE SPOTLIGHT

Anières graduate Daria Levitan studies at the Technion and runs her own business that teaches children to do quick mental mathematics. She sees her mathematics training centers as an opportunity to give back to the community, the way the Anières program supported her when she moved to Israel from Russia.



IMPACT IN LATIN AMERICA

ORT works in eight countries in Latin America.

In February, the Colegio Israelita de México ORT (CIM-ORT) unveiled an innovative urban garden, encouraging healthy eating and an understanding of the environment.

A team of students from CIM-ORT won the 2018-19 World ORT Taub Young Entrepreneurship Program (YEP). YEP promotes innovation, motivates students and encourages collaboration.

With a presence in countries from the Atlantic to the Black Sea, ORT provides numerous opportunities to contribute to, and benefit from, its educational and training programs.

FRIENDLY DEBATE AT INTERNATIONAL TOURNAMENT

Three 10th grade students from the Moscow ORT Technical School 1540 became the first Russian team to take part in the Parliamentary Debate World Conference (PDWC) competition in Japan in February.

EXPERIENCING ORT'S IMPACT

Members of the Jewish United Fund of Chicago (JUF) and Jewish Federations of North America visited the Sholom Aleichem ORT School in Vilnius, Lithuania.

Its Hebrew studies and STEM education program have contributed to the school's ranking as one of the best in the city helping it attract both Jewish and non-Jewish students in the community.

ORT's work in South Africa empowers teachers and improves literacy in townships, encourages budding entrepreneurs and provides job search skills and guidance.

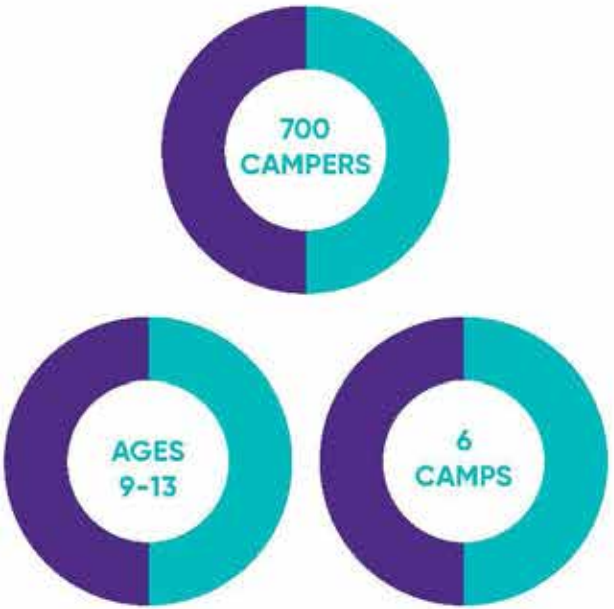
IMPACT IN NORTH AMERICA

Incoming Chairman Howard Lanznar shared ORT America's business plan to dramatically improve ORT's fundraising efforts in the United States over the next five years.



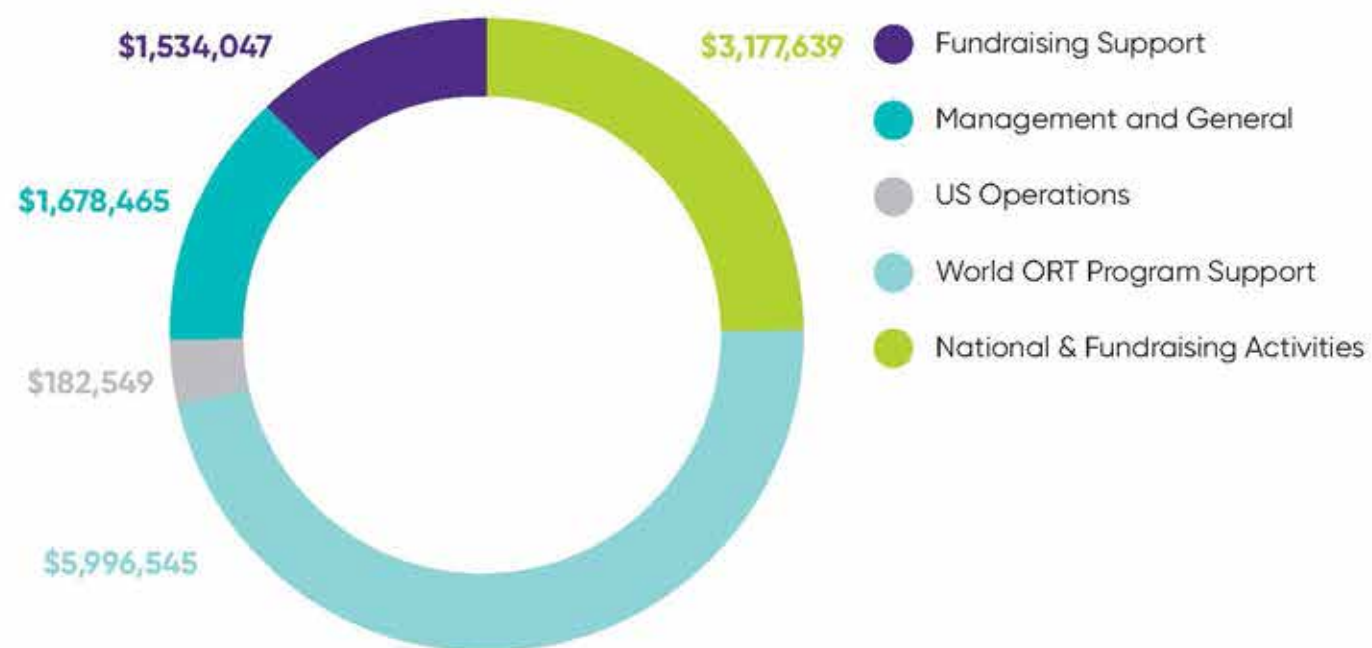
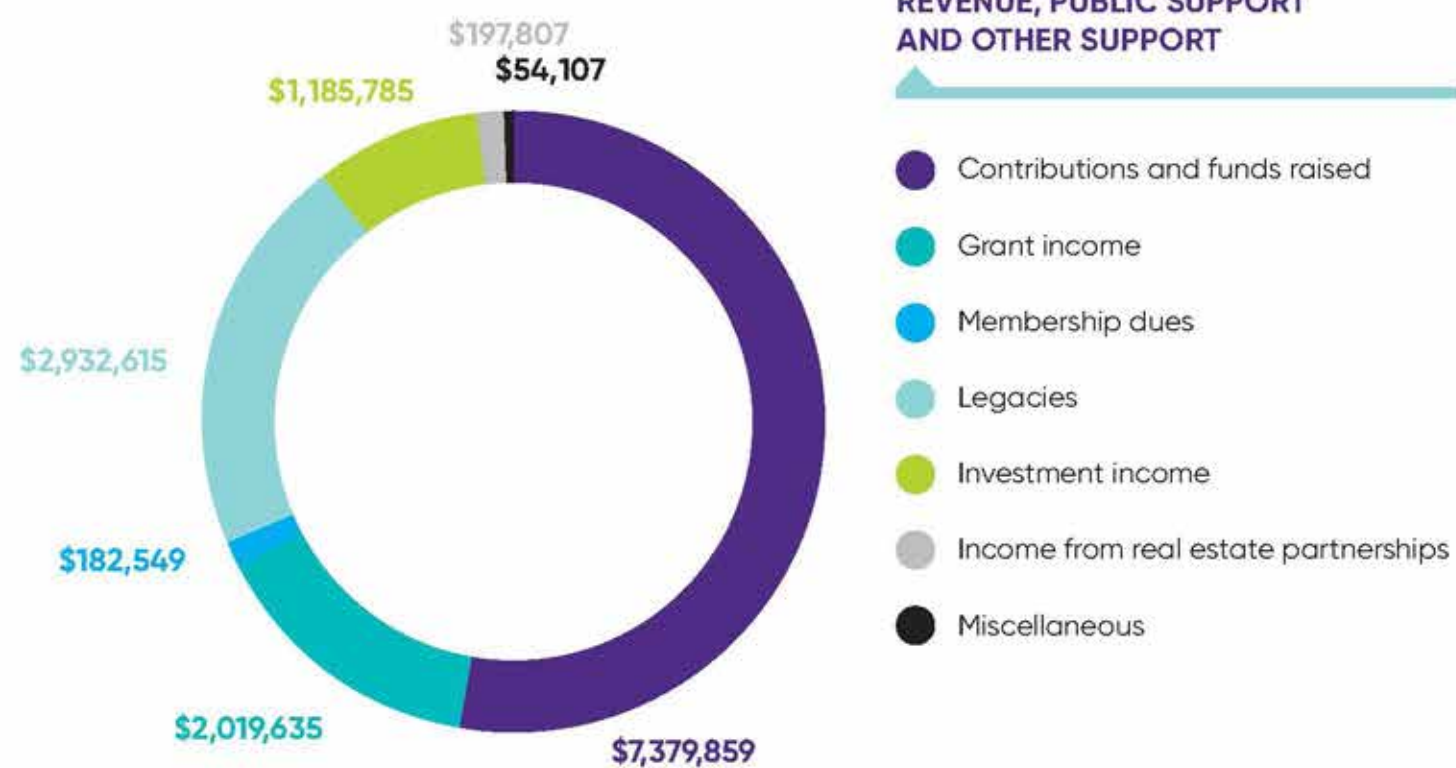
MAJOR DONOR RECEPTION
